- From I-84, take Exit 104 (Hwy 97- Bend/Yakima) that's the Biggs Junction Exit. Turn right, go through Biggs toward Wasco. Take the Wasco Exit (turn left towards Wasco) Go through Wasco; turn left at the "To Condon" sign (old yellow train station across from turn). You now will be on OR-206 going to Condon. At stop sign in Condon, turn right (OR-19); go through town—stay on OR-19 toward Fossil. About 10 miles out of Condon you'll turn right on Wehrli Canyon Rd. Buckhorn Road/Lane crosses Wehrli Canyon. Turn right on Buckhorn Rd.—follow road to gate (road veers left.) Continue through gate to house.
- Depart Bend on NW Wall St. (South-West) Turn LEFT (East) onto NW Colorado Ave. Turn LEFT (North) onto Ramp. Take ramp (RIGHT) onto US-97 [Bend Pky.] Keep STRAIGHT onto US-26 [US-97]. Keep RIGHT onto US-97. Bear RIGHT (East) onto SR-293 [Antelope Hwy.] Turn RIGHT (North-East) onto SR-293. Keep STRAIGHT onto SR-293 [South St.]. Bear RIGHT (East) onto SR-218. Turn LEFT (West) onto SR-19 [John Day Hwy.] Keep LEFT onto Greiner Rd. Turn LEFT (West) onto Greiner Ln. Road name changes to Buckhorn Ln. Follow road to gate (road veers left). Continue through gate to house.
