Grounds: VVFTA Grounds at LBJ Grasslands, CR 2675 & CR 2777. From U.S. Hwy. 380 North on FM730, go west (left) on CR 2175. At “T” (Old Decatur Rd., .8 miles), turn right. Head north (there’s a “Y” at the road sign), Bethel Baptist Church stay right on CR 2475. At Ball Knob Cemetery stay right on CR 2675; just past the Church there’s a “Y” and a stop sign, turn right. At the next “Y” you’ll go left (will be CR 2675). This goes up to the VVFTA entrance on your right. There is a vehicle/family usage fee and will be included in your entry fee at \$6.00 per day. Due to COVID-19, lunches and dinner may not be served on grounds. Federal grounds will require social distancing and face masks when gathered.

Campsites are available. No dogs or horses staked out in the camping area in trailer parking area.
